- 3) I willingly agree to comply with the stated and customary terms and conditions for participation. If I observe any unusual or significant concern or hazard during my presence, participation, and/or child's readiness for participation and/or the program itself, I will remove myself or child from participation and bring such to the attention of the nearest official immediately; and,
